

Rules and Restrictions

ELIGIBILITY: Entry purchaser, and anyone to whom an entry purchaser legally transfers an entry, must be either a business entity or an individual 21 years or older at time of entry purchase. Individuals buying on behalf of a business/legal entity must be legal representatives of the business and must, themselves, be 21 years or older at the time of entry purchase. Initial entry purchaser must be present in the state of Arizona at the time of entry purchase. Arizona residency is not required for purchase. Only one (1) individual may be identified as an entry purchaser. Entries may be purchased via the internet or through a designated Youth On Their Own Representative. Online entry purchasers will receive a confirmation email of purchase and hard copy tickets mailed directly to the Arizona address listed within ten (10) business days of purchase. In-person entry purchases will receive an immediate hard copy ticket, unless otherwise instructed by the respective Youth On Their Own representative. The ticket confirmation number is not required to claim a prize. Questions concerning ticket confirmation number(s) should be directed to Raffle Administrator Bethany Neumann via email bneumann@yoto.org. By entering the Raffle, the entry purchaser acknowledges that he or she is aware of, and agrees to abide by, the Raffle's rules and regulations. The Raffle Administrator and her immediate family members residing in the same household are ineligible to win a prize in the raffle. Purchasers do not need to be present during the drawing or attend the YOTO Fall Brunch to be eligible to win.

RAFFLE DRAWINGS: Only 250 tickets will be sold at the single price of \$100 per ticket. The draw will be held live on Sunday, November 3, 2019, at the YOTO Fall Brunch. Entries will be accepted until close of the formal event program, leading to the live draw. Prizes with the lowest suggested retail prices will be drawn first, progressing in order to the Grand Prize. After each draw, the winning entry number will remain removed for all subsequent draws, however, entry purchasers may win more than one prize.

PRIZES: The odds of a single ticket winning are roughly 1 in 83. The Grand Prize winner, when claiming his/her prize, will be provided the opportunity to accept either the trip as described or trip credit up to a total of \$5,000. The Grand Prize trip to Ireland, Scotland, or London is presented by AAA Arizona at Tucson East Branch, who is the Booking Agent. The Trip is listed to include the following, booked and secured through AAA Arizona Tucson East Branch: 7 day escorted European country tour including overnight lodging, 9 meals, sightseeing, airport transfers, and transportation while on tour. Double occupancy. Travel will occur in the Fall, Winter, or Spring, Purchaser may instead choose a \$5,000 travel credit with AAA Arizona at Tucson East Branch. Purchaser selecting this option will contact the Booking Agent to arrange a trip of their choice. Purchaser is responsible for trip costs that exceed \$5,000. Based on the chosen dates of travel by the purchaser, some lodging and/or attractions may not be available. Booking agent will seek similar or like experiences and accommodations in substitution at the sole discretion of the Administrator. Purchaser is responsible for securing/updating their own passports, recommended to be valid for at least six months beyond the travel dates scheduled. Purchaser is responsible for any recommended vaccinations. Purchaser is responsible for the cost of travel between the hotel and attractions as well as additional meals unless otherwise listed in the package offering. The Grand Prize winner of the trip must contact the Booking Agent to begin travel arrangements within 60 days of the drawing. Purchaser must provide at least 90-day advance notice with flexibility for booking arrangements. Trip must be taken within a year of the drawing date and is no longer valid after November 3, 2020. Gratuities, personal spending, travel insurance, and passport and visa fees, are not included. Trip operator and their employees are not responsible for passport, visa, entry, health, and oth

The second prize, White Stallion Ranch, is listed as an all-inclusive 2-night stay for two. Purchaser must use the package prior to the expiration date listed, January 15, 2022. Purchaser is responsible for making reservations for all items including lodging and activity participation in advance directly with White Stallion Ranch as directed on the certificate. Purchaser must bring the gift certificate at the time of redemption to be honored. Booking is subject to availability and blackout dates apply, including but not exclusive to Thanksgiving, Christmas, and Spring Break seasons. The third prize, two Casino Del Sol AVA Amphitheater 2020 season passes for entry to all AVA events scheduled that season unless otherwise notified by the venue. Passes are only printed once. List of performances will be released by AVA in 2020.

Transfer of prizes is permitted with proper transfer documentation bearing notarized signatures. Prizes may also be donated back to Youth On Their Own.

NOTIFICATION OF WINNERS: All winners will be notified via mail by the Raffle Administrator of the requisite procedure to claim the prize. All Prize winners must claim their prize within fourteen (14) calendar days of the draw. The Grand Prize winner of the Trip to Europe or customized location that does not exceed \$5,000 is required to contact the provider to begin trip booking within 60 days of the drawing. The remaining prizes are subject to availability with blackout dates. The trip and hotel stay require advanced notice to book reservations. Three (3) business days after the Draw, a complete prize winners list, displaying first and last names of winners, will be available on the yoto.org website. Using the information provided, if a selected winner is unable to be contacted or located prior to the deadline for claiming the prize, the prize will revert to Youth On Their Own. In the event a winning entry has more than one name listed, the Raffle Administrator will physically award the prize to the first name listed on the entry. For tax purposes, the prize can be split among all verified prize winners. Youth On Their Own nor their legal counsel are responsible for resolving disputes which may arise from any conflict between or amongst joint ticket holders or purchasers.

PRIVACY: By entering the Raffle, entry purchasers agree that their information provided in connection with the Raffle entry may be used for communications promoting the Raffle and future raffles sponsored by or conducted for the benefit of Youth On Their Own. An entry purchaser may subsequently "opt-out" of the receipt of Raffle communications by following the directions in any email or by contacting the Raffle Administrator. Other than as provided herein, or as required by law or court order, an entry purchaser's information will not be shared with or sold to any other person or entity. Purchase of an entry in the Raffle constitutes permission for the Raffle and Youth On Their Own to use winner's name, and/or likeness, in perpetuity, for purposes of advertising the Raffle or future raffles without further consent or compensation, unless prohibited by law.

REQUIREMENTS: Potential winners must complete all steps outlined in their winners' letter within the designated timeframe. If an entrant is found to be ineligible, or if a potential winner does not comply with the Official Rules, then the potential winner will be disqualified and the prize will revert to Youth On Their Own.

RAFFLE CANCELLATION: In the unforeseen event the Raffle is cancelled or cannot be completed, every effort will be made to refund the ticket purchase price to all Raffle ticket purchasers. Tickets purchased by credit card will be refunded to the credit card holder's account. Youth On Their Own liability to any ticket purchaser is limited to the purchase price of the ticket.

WAVIER / LIMITATIONS OF LIABILITY: Except as described in the previous paragraph, entry purchasers, by participating (and winners, by accepting a prize), release Youth On Their Own and their respective affiliates, partners, subsidiaries, agents, representatives, sponsors, service agencies, and independent contractors, and each of their respective directors, officers, partners, employees, and agents, including advertising and promotion agencies, from any and all liability with respect to participation in the promotion, possession, use, and distribution of the prize(s) awarded. In the event a dispute shall arise between the purchaser and Youth On Their Own and/or its representatives, any controversy or claim arising out of or relating to the raffle shall be-resolved in Pima County Justice of the Peace Court.

INTERNET: The Raffle will pursue all available legal remedies against any individual(s) damaging or attempting to damage any Youth On Their Own website or attempting to undermine the lawful operation of the Raffle.

FORCE MAJEURE: Neither Youth On Their Own, AAA Arizona, nor other prize providers shall be in default or otherwise liable for any delay in or failure of its performance of the Raffle if such delay or failure arises by any reason beyond reasonable control, including any act of God, any acts of the common enemy, the elements, earthquakes, floods, fires, epidemics, riots, failures or delay in transportation or communications, or any act or failure to act by the other party's employees, agents, or contractors.

GOVERNING LAW: Should a dispute arise between a purchaser and Youth On Their Own and/or its representative, purchaser agrees that all cases, controversies, and legal issues shall be governed by the laws and jurisdiction of the State of Arizona.

TAXES AND IRS RULES: All winners shall be responsible for any and all federal state and local income or excise taxes, fees, assessments, and like charges associated with the prizes.

SPECIAL NOTE: At the time of this printing, federal law requires that corresponding tax withholding on prize values of \$5,000 or greater must be collected from winners. Federal and state withholding laws are subject to change without notice. The withholding laws in effect at the time prizes are claimed will be followed.
