1. Call to Order Sean Denlinger

#### **6. Approve Finance Report**

Deb Salaiz/Todd Brown

Deb shared the finance summary provided to the board with no concerns. Deb shared that we are healthy with a burn rate of 4 months without investments and almost 17 months with investments.

Todd worked with Beach Fleischman on YOTO's application for the Employee Retention Credit (ERC). We qualified for credits for both Q2 and Q3 of 2021, for a total refund of \$393,000.

#### 7. Review and Approval of Financial Reserve Policy

Deb explained that YOTO will maintain three types of reserve funds: Operating Reserve, Capital (Property) Reserve, and a Quasi-Endowment. The purpose of a Financial Reserve Policy is to articulate how the organization will use surplus unrestricted donations and establishes minimums and targets for each of the distinct funds.

# 8. Approval to pay off Line of Credit

Deb explained that YOTO purchased the new property with mostly cash, but accessed our Line of Credit for \$277,254.97. The Finance Committee recommends paying off the Line of Credit as soon as possible. This complies with the recently adopted Financial Reserve Policy.

### 9. CEO Report & Building Update

Elizabeth Slater

Elizabeth shared these updates:

- 2022 theme for YOTO is "Mission Obsessed"
- COVID policy has been updated to align with public health guidance
- Data on enrolled students: Demographics, common reasons for homelessness, and most common living situations
- YOTO will not hold a Spring Lunch but will instead announce the new building via social media campaign

Elizabeth presented the following building updates:

- Huge dead tree removed (agents paid)
- General clean-up and tree trimming will happen soon
- Elizabeth and Todd working on comprehensive Scope of Work for architect bid process. The New Space Committee will participate in selection process.

Elizabeth reported the following exciting news:

- YOTO has been invited to present our request to Angel Charity for \$750,000 to pay for renovations
- If selected, we will not do a traditional capital campaign
- Angel Charity will have exclusive naming rights of the Youth Services building
- Elizabeth and her dream team will present on February 3 if selected as a finalist, we will present again in March

# 10. Training: Nonprofit Advocacy

Frank Velasquez

Frank provided a presentation on the important role of advocacy in nonprofit leadership and dispelled myths regarding advocacy versus lobbying.

Frank led an activity to allow the group to brainstorm ways YOTO can enhance its advocacy efforts in four areas (ideas shown in parentheses):

- Inform & activate your network (social media, word of mouth with circle of influence)
- Research impact of policy issues (ask youth what impacts them, issues in community)
- Educate policymakers & the public (speak at events, contact lawmakers, invite major/press to ribbon-cutting, highlight things in news during donor calls, advertise, social media, TikTok, offer free table at events)
- Join forces to create a louder voice (join forces with another organization such as Our Family Service to help us voice the housing need)

Frank, Lorenzo, and Elizabeth reviewed YOTO's current advocacy activities. Lorenzo shared the Advocacy Committee's goals for 2022:

- Recruit committee members
- Present an advocacy policy to the board for approval
- Determine messaging priorities (relationship-building, education, media, legislation, policies)
- Explore filing the 501 (h) Election in case YOTO decides to engage in lobbying in the future
